No.LC-TR-52/2012 4179 /T. In exercise of the powers conferred by sub-section(1) of section 200 of the Motor Vehicles Act, 1988(59 of 1988), the State Government do hereby specify the Police Officers not below the rank of Sub-Inspector of Police of the Commissionerate of Bhubaneswar-Cuttack and Municipal areas of Rourkela, Sambalpur, Berhampur, Puri and Keonjhar to compound offences committed under different sections of the said Act and the rules made there under and punishable under sections 177, 179 and under sub-sections (1) and (2) of section 183 of the Act, within their respective area as stated above for a period of one year with effect from the date of publication of this notification in the Odisha Gazette for an amount of penalty which shall not be less than fifty per centum of the maximum fine provided for the offence under the said Act.
