The applicants must have passed at least upper primary examination in Odiya. Candidates with proficiency in Computer / Driving / Electrician / Motor Mechanic / Plumber / Carpenter / Mason/ Barber shall be given preference. Mention it in the application form under point 7 (special qualification).

**PHYSICAL FITNESS :**

Applicants must have physically / mentally fit. The candidates shall be well prepared for medical tests, physical efficiency test and technical tests for example driving test, Computer test and other tests as per the special qualification mentioned under point-7 of the application form.

I declare that I am citizen of India and that I desire to be enrolled as a member of the Home Guards for Odisha and have no intention of permanently leaving the limits of the Odisha State for at least three years after enrollment and that I am not under any obligation to serve in any other force.

I understand that:-

(1) In any emergency I shall be liable to be called out on duty at any time and for any period and in any part of the State of Odisha;

(2) I shall be liable to undergo training and attend parades in accordance with the orders of my superior officers;

(3) I shall be required to take the following pledge, namely:

"I.....residing at .....do solemnly and sincerely declare and affirm that I will well and truly serve, the Government of Odisha as member of the Home Guards without favour or affection, malice or ill-will or communal or political bias; and that I will, to the best of my powers, discharge the functions and duties assigned to me for meeting any emergency, and for serving the people in any calamity and for the protection of persons, the security of property and the public safety and that I will, to the best of my skill and knowledge, discharge all the duties as such member, faithfully according to law.

(4) I shall be required to serve for a period of three years in the Home Guards unless I am allowed to resign in pursuance of the Odisha Home Guards Rules, 1962.

(1) If you are a Government servant or an employee in a local authority, a firm or any other office, you should send this form through your superior officer with his certificate that he has no objection to your attending the training and that he will release you for duty in an emergency at any time and for any period and in any part in the State of Odisha.

(2) After completing the form you should post it or deliver it to the Commandant, Home Guards of the District. You will receive intimation in due course, whether your services can be utilized.

(3) In requesting the employer or the superior officer to issue certificate mentioned in (1) above it may be pointed out that emergencies such as those that are referred to in paragraph (1) are not likely to arise very often. Prospective Home Guards should therefore not be scared away nor their employees, or superior officers, hesitate to issue the above certificate for just this reason.
